#### **RULES & REGULATIONS FOR ADMISSION**

Parents/guardians desirous of taking application form for registration of their children for admission, are requested to note the following important rules, regulations, terms and conditions in respect of registration, admission and withdrawal.

- 1. One Application Form is for one student only.
- 2. Application for Admission will not be accepted unless complete address along with pin code and telephone number is mentioned.
- 3. Transfer Certificate and Original Memorandum of Marks should be submitted, if not admission will be cancelled and fee shall not be refunded.
- 4. The College reserves right to withdraw admission of any student on following grounds:
  - a) For indiscipline or misconduct.
  - b) Failure to pay college dues.
  - c) For not abiding by rules and regulations of the college.
  - d) For being irregular to college.
- 5. The tuition fee can be paid in two installments. The first installment must be paid at the time of admission, the second installment by 5th December.
- 6. The fees is to be paid either in cash or by demand draft. Cheques will be subject to clearance. In case of cheque bouncing, the amount will be charged to student account.
- 7. The college fee must be paid in time. Late fee of Rs. 100/- will be charged for the first 5 days after the due date, Rs. 250 will be charged if fee is further delayed even beyond the 5<sup>th</sup> day until the 10<sup>th</sup> day. After 10 days, the admission will stand cancelled and the student's name will be removed from the rolls.
- 8. Fee once paid will not be refunded or adjusted or transferred to any other student under any circumstances.
- 9. Those who are admitted into the college and who subsequently wish to withdraw (during the academic session) for any reason, will not only have to forfeit the entire fees paid but will also have to pay tuition fee for the remaining course of 3year.
- 10. In case of long leave or absence, concession given in fees will be cancelled.
- 11. Discontinuation without information will amount to forfeiting of the entire fees. No claim whatsoever either for admission or for refund will be entertained.
- 12. There will be 10% enhancement in the second & third year course existing fee.
- 13. Concession in fees is given only in tuition fees. There will be no concession in lab fees.
- 14. Absence for more than 10 days without prior permission from the principal, will require readmission.
- 15. In case of prolonged sickness and absence, Medical Certificate issued by a Civil Surgeon should be submitted.
- 16. Dress Code: Students should come to college decently dressed.
  - They are permitted to wear only salwar suits. Students are not permitted to wear heavy/garish make-up.
- 17. Wearing valuable jewellery, watches etc., also carrying heavy cash to college is not advisable. The college will not be responsible for any loss or damage or theft to your belongings.
